## Dear investors,

We the undersigned support the <u>call from the Hereditary Chiefs of the Wet'suwet'en</u> – namely Chief Na'Moks, John Ridsdale T'sayu, Hereditary Chief Woos, Frank Alec Cassyex and Hereditary Chief Howilhkat for Chief Knedebeas, Freda Huson Cilhtsekhyu – for you to **not participate in the purchase of bonds by Coastal GasLink/TC Energy** that are being facilitated by Canada's big six banks: RBC, Scotiabank, TD, CIBC, BMO and National Bank. The owners of Coastal GasLink are TC Energy, KKR and the Alberta Investment Management Corporation.

Coastal GasLink is beginning to operate a 670 km fracked gas pipeline that has been built without the consent of hereditary leaders in many of the territories it crosses. It is only through heavy militarized and often violent support from the federal Canadian police that this pipeline has been built. It has been subject to several reports by the UN Special Rapporteur on the Rights of Indigenous Peoples, José Francisco Calí Tzay. The pipeline has suffered numerous regulatory infractions, and faced significant cost overruns and delays.

If additional compression infrastructure is approved and built, the pipeline will have the capacity to transport 5 billion cubic feet of fracked methane gas per day. When burned, this will produce emissions <u>equivalent</u> to burning over 300 million pounds of coal, or driving more than 65,000 passenger vehicles for a year per day.

We expect methane leaks along the route, as is the case with most fracked gas pipelines and these are not accounted for in the above numbers. At a time when the world has experienced the hottest year on record, wildfires have already broken out in Canada, and the <u>United Nations</u> and <u>IEA</u> have both stated the world does not need further fossil fuel infrastructure, we believe that any investment in this project is both morally reprehensible and financially risky.

As investors, you have the responsibility to ensure your returns are not generated through violating human rights, polluting the air and water of communities, or contributing to increasing climate-heating emissions. In addition to the obvious reputational and climate risks of continuing to fund expansion of this controversial project, we urge you to consider the financial risk of investing in a project with a history of delays, ballooning budgets, operating without consent and and likely facing a future stranded asset risk.

## We urge you to refuse to participate in this bond sale.

We look forward to hearing your response and confirmation.
